#### **Welcome** – Clint Smith

- The meeting was called to order at 9:00 a.m.
- Introduction of Executive Committee & Guests
- Congratulations to both Chief Miquel and Guy Dansie on their upcoming retirement

### **Minutes Approval**

January 18, 2023 Winter Business Meeting minutes

Joseph Mittelman motioned to approve the minutes from May 11, 2022 Craig Golden seconded the motion All voted in favor, none opposed

#### **Financial Report** – Brad Hannig

- Chief Hannig provided an update to finances for USFCA
  - The current balance is \$37,870
  - This balance has been reduced with the costs of the January leadership training and business meeting in St. George
  - Chief Hannig reminded members that the association relies on both sponsorship and membership dues

#### **Board Elections**

- Jeremy Craft has moved to the Vice President role for Western Fire Chief's
- Due to this change, elections will take place this meeting
- Kevin Ward has become the Western Fire Chief representative
- Clint Smith has become President
- Riley Pilgrim, 1<sup>st</sup> VP
- Brad Hannig, 2<sup>nd</sup> VP
- This movement has resulted in an opening for the Secretary/Treasurer
- Daniel Gallegos, HAFB was nominated for Secretary/Treasurer
  - There were no further nominations
  - Ted Black moved to close nominations and move Daniel Gallegos over by acclimation of the body
  - Dave Olson seconded the motion
  - o All voted in favor, none opposed
  - o Daniel Gallegos accepted the position
- As a reminder, the Volunteer Fire Chief Liaisons is Brett Pierson
  - This position was implemented last year and helps increase the reach of the USFCA across the state

## Western Fire Chief's Report – Kevin Ward

- Kevin Ward provided an overview of the work WFC is doing
  - o Looking for ways to enhance the job using the latest and greatest in model policies, technology, and innovation
  - Much work is taking place, currently mostly in WL fire policy, with a Legislative Committee
    - Driving legislation to help deal with fire problems throughout the country

- Working to develop model legislation
- o PulsePoint is another aspect of focus that WFC hopes to enhance
- o Encouraging diversity, quality, and inclusion in the Women in Fire Program
  - Chief Ward asked members to encourage their female FF's to get membership and access the great resources offered through this program
- o Daily Dispatch
  - Encouraged members to sign up for this daily news source
- The WFC website offers various podcasts and leadership related information for members
- o Reminder that August 15-18, 2023 is the IAFC Conference

## **Legislative Update**

- Dave Spatafore and Ashly Mirabella provided an update to legislation, information on what will happen before the next session, and what is needed to prepare
  - Ambulance Transports
    - The intent is to change the wording, but not provide medical services
    - This is in order for ambulance companies to receive medical payments for Medicaid through the Health Department
    - If interested in joining a workgroup, there is a need for a legislative workgroup
  - o BEMS to DPS
    - The goal is to be a part of this from the beginning
    - Commissioner Anderson wants to get things up and running and will be attending next month's legislative meeting
    - EMS will go from Health Department to DPS, and they have until 7/1/24 for that change to occur
    - The intent is to ensure EMS is the top of the line, not just a bureau to be forgotten
  - Mental Health Services
    - Many of the smaller agencies are having difficulty with the provision of services to first responders, families, and retirees
    - This is only 1-time grant funding
    - The plan is to look at this holistically at possibly a state-run program that agencies pay into in order to receive services, state and locally funded
    - This may be a more effective way to provide and deliver services, helping to reach the goal of providing better services to all
    - There aren't enough professionals to support a program wherein each agency has their own
    - Will work to hopefully put something together for all agencies to participate in
  - HB145
    - Study on WL risk and mitigation
  - HB261 WL Mitigation Account
    - Working to stay focused and coordinate with FFSL to keep moving forward on mitigation
    - This bill would put monies into a mitigation account
    - There are becoming more areas throughout Utah where insurance companies aren't wanting to insure homeowners and this is something to keep an eye on

- o HB61 School Safety
  - It has already been established how both public and private school safety plans are overseen
  - Making sure all the gaps are covered, will continue to watch this
- Annual Bomb Squad Funding
  - The equipment is outdated for 8 local bomb squads
  - As there is no state bomb squad, the reliance is on local squads
  - \$2.2M was received to update the equipment
  - The goal is to get more small funding until the equipment is replenished and then annual funding and training from the state
- o SB21 2018
  - Addresses if PD or FF dies outside the line of duty after 20 years of employment, but not retired, the death benefit is only 37%
  - This was due to a technicality, the intent was to insure
  - The goal is to have this retroactive to January 1, 2023
  - The bill will pass, the only questions is retroactivity
- Legislative Committee
  - UFA hosts a meeting each month to discuss legislative direction for the fire service
  - If interested, please reach out

## **Utah EMS Report** – Guy Dansie

- Move to Public Safety
  - Will be meeting with Commissioner Anderson to discuss staffing, positions, and internal challenges with the upcoming move to Public Safety
  - Also looking at data; it's use, sharing, and regulation
  - There is an opening on the EMS Committee for a representative
    - This is a governor appointed seat, but he considers recommendations from BEMS
    - This seat is for representation from a Class 3 or smaller
- Volunteer Insurance Fund
  - o A good conversation took place in April about extending this out
  - o Only 30 are enrolled, but funded for 180
  - Considering reducing the criteria to allow for more open-ended opportunities for volunteers in rural counties
- Rate Rules
  - This is in the queue for public comment
  - With the rate change, 9% base rate, 9% mileage, it sounds like significant revenue, but in actuality, only a 2% net revenue will be realized
- PEHP/BCBS
  - The discussion is to look at the average cost per patient rather than itemizing for each patient
  - o The idea is to simplify billing, but not harm services and revenue
  - The discussion is ongoing

#### UCA – Tina Mathieu, Acting Director

- Coverage is expanding, there are plans to build approximately 18 new sites in the coming 4-5 months
- P25 Update
  - O Coverage testing will begin in the Southeast area and continue for 12 weeks
  - o Testing will take place on over 100,000 cell sites
  - A fleet map is being prepared with a completion time of Feb/Mar 2024
    - Agencies can expect to be contacted in the coming weeks
    - Veenendaal is happy to come to your agency to help with maps to build the coplugs and program radios
  - O UCA can help with programing of the L3H radios if necessary
    - Will also program the Motorolas as UCA moves into your area for the transition
  - There is still some ARPA Funds available for L3H radios at 65% off until the end of June
- L3H has been installing interoperability gateways at PSAPS
  - o This will bridge to the P25 system and temporary bridges
  - o Most consoles have been installed at the PSAPS, only a small handful are pending

#### ■ SB212

- o Dave Spatafore stated that this bill is supposed to be non-controversial and easy
- During the session, two new versions of the bill were released
  - The first version had UCA losing their independent status to fall under DPS
    - This would cause no opportunity to have that communication and independence
    - This would further distance UCA from local governments
  - The second version left UCA independent, but with governor appointed leadership
- o The bill is now back on track and there have been changes in administration at UCA
  - Local agencies should have input and not beholden to the state
- UCA independence should be a priority and make sure to have a voice in the director process

## **Communications Report** – Mike Phillips

- Fleet Mapping
  - Chief Phillips discussed the advantages of community talk groups rather than each agency having their own and needing to switch channels all the time
  - o This will help make great strides in interoperability
  - o Region Channels can be used and programmed on the UCA system and available only in that region
  - The whole fleet map concept is talking within your area/region
  - This mapping is for regional groups who need to communicate initially, but will then expand beyond
  - There is the ability to program your own radios, there will be a certification class offered late summer

#### **State Fire Marshal's Report** – Ted Black

- License Plate Grant Award
  - o The notifications should be out by now
  - The grant close date will be changed to get away from the legislative session and moved to fall
  - o Ted encourages all agencies to apply for the grant
- Fire Prevention Focus
  - o Ted encourages all to make Fire Prevention a priority within your departments
  - The prevention program is directly responsible for less fire and loss
  - Make this division attractive to those within your departments, make it worth their time to work in Fire Prevention

#### **UFRA Update** – Brad Wardle

- Operations Side Marc McElreath
  - o All the student registrations, consent forms, surveys, are all online now
  - o The next step is a program called Resource1
- Hiring
  - O Conducting hiring in targeted areas in the state where Fire 1 instructors are needed
  - Southern Utah is the initial focus, then moving to Northern and doing the same there
- Standard 103
  - Currently working on the curriculum
  - Expect the pilot program in July
  - The group who developed the standards is developing the curriculum
- Highrise Class
  - Pilot classes are being conducted to collect feedback for delivery at Winter Fire School
  - o The 1st class was held last week, the next classes will be held in Lehi and Ogden
- Auto Extrication
  - UFRA has 3 sets of extrication equipment
  - One set will be rotated out of use each year, if anyone is interested in obtaining this equipment it will be available at a reduced cost
- Winter Fire School
  - o January 18-20
- The new Fire School props are pending, and the old ones are being refurbished
- Anyone interested in IFSTA books, UFRA gets a discounted rate
- Training
  - Starting the National Fire Academy Classes
    - If interested in hosting, please reach out to Dennis Goudy
- Straight Tip will be going digital, there will no longer be a hard copy
  - O Digital copies will be sent to each station and fire chief
  - o This will save \$50,000 to apply to academy training programs
- Water mapping class offering hose line advancement
  - o Train the Trainer, if interested, will take place April 17, 2023
  - o General classes begin April 18, 2023
- Certification Division
  - o Provided a brief overview of new and additional certification classes

- Moving from paper testing and grading to electronic
  - This will allow for no delay in notification if passing

## WL Update - Riley Pilgrim

- The Western Wildfire Committee and the IFC are working on legislation
  - o Direct benefits may not be seen immediately, but there will be a trickle down
  - Collaboration continues on best practices
- Insurance Issues in the WL interface areas continue
  - O Homeowners are facing the impacts and much work is being done on how to help
  - o The message is we are doing as much as we can, but it is their responsibility
  - At the national level, the insurance issue is everywhere, and it is being looked at and tackled in creative ways
  - Western Wildfire Committee is putting a lot of effort and money into research with the hope to make some impact
- Credential Qualifications on Structural Side
  - o A lot of work is being done on the national level
  - o US Fire Administration and FEMA are working to create and provide information in Crosswalk, so we should be seeing some impacts from this soon
  - NWGC working on a bridge for the gap to work toward making the process easier, this is a big push as they are running low for qualified individuals once they get to Type 1 & 2
  - Working on a new process to develop complex teams and move away from Type 1 & 2
    - This in theory will open more doors for opportunities
    - Practice is different than concept, so will see how this works out
- EMAC Season
  - o Trainings will take place both in-person and virtually
  - Some issues continue to tie up all reimbursements
- URS Legislative Issue
  - o A brief survey will be sent to all Division A and B chiefs
  - They want to find out who is Division A/B and if any deaths have taken place
  - o This will help legislators understand where these situations may have occurred and the challenges the families or departments have seen

#### **Unfinished/New Business**

- FFSL Update and New Rate Discussion
  - Updated personnel changes in WUI
  - o There is a vacant Deputy Director position
  - o The Southwest FMO has been hired
- UCAC
  - Compiled a work group to address various issues
  - Looking at apparatus rates and have develop a process based on replacement intervals
  - Calculations have been used to develop hourly rates so replaceable after 15 assignments
  - Used some historic knowledge on costs for mileage rates

- o Will be tracking mileage so will have an hourly and mileage rate documented
- o Looking at true personnel costs
- o Some adjustments have been made for more accuracy, using an 18-day average period that compensates for R&R and accounts for sick and backfill
- O The same work was done for standard rates

- Galleri Cancer Screening Mary Nothum
- Responder Solutions Melanie Squires
  - Melanie is a trauma therapist who can train peer support, teach skills and conduct assessments
